Under power delegated by Govt. and as per rule laid down in Meghalaya Delegation of Financial powers Rules 2006, sanction is hereby accorded to an expenditure of Rs. 8,65,200/- (Rupees Eight lakhs sixty five thousand two hundred) only for implementation of the following scheme under General CD programme 2013-14 in the Mawshynrut C&R. Dev. Block (Stage II) on the following conditions:

1. Diversion of Fund from one Sub-head to other is not permissible.
2. The scheme should be implemented immediately and the details of each scheme should be finalised by convening meeting of the Sub-Committee, if not already done
3. The amount should be utilised within the current financial year.
4. The existing rules and procedure for drawal, disbursement of money and implementation of the scheme should be strictly adhered to.
5. Monthly Progress Report of expenditure and physical achievement should be submitted regularly.
6. The scheme should be implemented as per technical estimates duly approved by the technical Heads of the Development Department.
