SANCTION ORDER

Under power delegated by Government and as authorized vide Department Notification No.FEG.30/76/90, dt.14.06.91 sanction is hereby accorded to an expenditure of **Rs.5,00,000/- (Rupees five lakhs)** only for implementation of projects under Construction of Rural Road Programme (CRRP) for the Year **2014-15** in **Mawthadraishan** Community & Rural Development Block as detailed given in the Annexure-I(enclosed).

The sum of **Rs.5,00,000/- (Rupees five lakhs)** only is sanctioned subject to the conditions that the scheme are implemented as per CRRP guidelines and Govt. instructions issued from time to time and also on the following conditions which is as per guidelines.

1. The CRRP Schemes shall be directly implemented by the beneficiary-Organisation/ Local Managing Committee to be recommended by the MLA concerned and the Utilisation Certificate(s) must be countersigned by the concerned MLA before the same is/are submitted by the beneficiary Organisation/Local Managing Committee to the Block Development Officer.
2. The Block Development Officer shall release such amount as the 'First Installment' to the beneficiary Organisation/Local Managing Committee of the sanctioned scheme for implementation, subject to the 'Utilisation Certificate' should be furnished by such Organisation/Local Managing Committee within a period of four months from the date of release of first installment, certifying that the amount has been fully utilized for the purpose for which it was sanctioned.
3. The Secretary shall maintain a separate Cash/Subsidiary Cash Book for the amounts received for the scheme and shall be responsible for the proper maintenance of all books of accounts and records such as, Plan and Estimates; Muster Rolls, Materials/Articles so received and purchased and shall ensure submission of Utilisation Certificate at regular interval.
4. The Secretary shall produce all relevant books, records to audit party or any authority as and when asked for.
5. On the receipt of such Utilisation Certificate, it shall be verified by the BDO or his authorised Subordinate Engineer, where utilization of the amount is found to be correct and actual, the BDO shall countersign the Utilisation Certificate and submit it along with the demand statement for the release of SECOND/THIRD/FOURTH Installment.
6. The President or the Secretary or both as the case may duly authorised by the concerned Local Managing, Committee/ Beneficiary Organisation shall receive the fund and the fund as received shall be entered in the Cash Book and then deposited in the Bank Account to be operated jointly by the President and the Secretary or the Secretary and the Treasury authorised on their behalf by the concerned Local Managing Committee/Beneficiary Organisation.
7. No contractor(s) shall be engaged either by the Block Development Officer or the Beneficiary Organisation/Local managing Committee for implementation of CRRP Schemes.
8. The Monthly Progress Report in the prescribed proforma on the progress of implementation of each project by the Block should be submitted within 5th of each month without fail, for onwards submission to the Director of Community & Rural Development, Shillong within 7th of each month.
