SANCTION ORDER

Under power delegated by Govt. and as per Rule laid down in Meghalaya Delegation of Financial Powers Rules 2006, sanction is hereby accorded to an expenditure of **Rs.9,07,134/-**(Rupees nine lakhs seven thousand one hundred thirty four) only for implementation of Projects under Special Rural Work Programme (SRWP) for the Year **2013-14 ((100%))** in the Mawshynrut Community & Rural Development Block as detailed given in the Annexure-A (enclosed).

The sum of **Rs.9,07,134/-**(Rupees nine lakhs seven thousand one hundred thirty four) only is sanctioned subject to the conditions that the schemes are implemented as per SRWP Guidelines and Govt. instructions issued from time to time and also on the following conditions which is as per the guidelines.

1. Para 4.10 of Comprehensive SRWP Guidelines makes its mandatory to maintain the quality of materials/articles being procured under the scheme. A Block Tender Committee for purchasing of all items under the schemes should be constituted by Block Development Officer at Block Level and Block Development Officer to act as Member Secretary under the Chairmanship of MLA of the Constituency or any Member nominated by the MLA for implementation of the scheme regarding purchasing of materials and articles.
2. A notice inviting Tender should be issued by Block Development Officer indicating specification of materials/ articles and a copy of Tender Notice should be marked to the office of the undersigned.
3. A Copy of work order/ supply order to be issued to suppliers should be invariably marked to the office of the undersigned.
4. Block Development Officer shall maintain records of Materials/articles received which is to be distributed to the beneficiaries.
5. Payment should be made to suppliers for supply of Material/articles after Block Development Officer has satisfied that the quality & quantity of materials/articles received by him are as per specifications indicated in the work order & Supply order.
6. The Monthly Progress Report on implementation of each Scheme should be submitted within 5th of every month without fail, for onwards submission to the Director of Community & Rural Development, Shillong within 7th of each month.
7. Block Development Officer, is to submit the Utilisation Certificate and completion Report duly signed by him after completion of the scheme.


