5. Progress of implementation should be reported in prescribed format Annexure IV.C. and IV.D for Uploading and Updating data in the MPLADS website.
6. The BDO to cause inspection of the schemes/projects implemented and an inspection report thereof to be submitted to the office of the undersigned.
7. The BDO should ensure that a Sign Board/Plaque at the site of the project of stone/ metal. carrying inscription of particulars of the project is permanently erected..
In addition, the scheme should be implemented as per MPLADS Guidelines and Government instructions issued from time to time.


